Open to all artists 18 years old and over.  
Artwork to be hand-delivered to the Arts Center of Tolland, 22 Tolland Green, Tolland CT.  
Original artwork only; no reproductions, no crafts, no photography, no sculpture.  
Works should be wired and ready to hang.  
No tooth-hooks will be allowed.  
Works previously exhibited in any Arts of Tolland Juried Show are not eligible.

### PICK-UP

All non-accepted entries MUST be picked up on Monday, April 4, from 4 p.m. to 6 p.m.

Accepted entries are to be picked up on Sunday, May 4, from 4 to 6 p.m. No early pick-ups.  
Paintings not picked up are subject to a \$5 per day storage fee.

**JUDGE: Sandra Wakeen** is a nationally and internationally known painter and teacher who studied at Paier School of Art, Studio Escalier in France, and at Scottsdale Artists School, where she studied forensic facial reconstruction. She was accepted recently into Oil Painters of America Inaugural Salon Show, and was one of 35 artists accepted into Plein Aire Vermont. She was a featured artist in *Fine Art Connoisseur* magazine and *American Art Collector* magazine. Oil Painters of America and the Portrait Society of America have recognized her work, and the Greater Hartford Arts Council in 2012 named Sandra "Connecticut Artist of the Year." She has exhibited throughout New England and in Italy. Currently she paints and teaches at her studio in Somers, CT.
